SEALED BIDS for **JOB NO. 2025-1256, FURNISHING AND DELIVERING A 800KW GENERATOR SET**, North Kona, County of Hawai'i, State of Hawai'i, will be received ELECTRONICALLY by the Department of Water Supply, County of Hawai'i, until **March 27, 2025 at 2:00 p.m.** when they will be publicly opened and read aloud. Bids received after the time fixed for opening or delivered elsewhere other than specified herein will not be considered.

This project generally consists of furnishing and delivering an 800kW generator set, including sound attenuating container, exhaust system, sub-base fuel tank, trailer, supports, accessories and incidentals, in accordance with the specifications.

A pre-bid meeting shall be scheduled for **March 12, 2025 at 10:00 a.m.** at the Hualalai Well site, refer to Special Provisions section for site location. A site visit shall immediately follow the pre-bid meeting. 
